PURPOSE

This policy explains how Carlton North Primary School (CNPS) proposes to manage common enquiries from parents and carers.

SCOPE

This policy applies to school staff, and all parents and carers in our community.

POLICY

CNPS understands the importance of providing helpful and timely responses to common enquiries from parents and carers. To ensure that members of our school community are directed to the most appropriate person to assist them, the information below outlines key contacts for common queries:

- to report a student absence, please enter the information on Compass, or contact the office on 9347-4822.
- to report any urgent issues relating to a student on a particular day, please contact the office on 9347-4822.
- to discuss a student's academic progress, health or wellbeing, please contact your child's classroom teacher by email or on 9347-4822.
- for enquiries regarding camps and excursions, please contact your child's classroom teacher by email or on 9347-4822.
- to make a complaint, please contact your child's classroom teacher, the Team Leader of your child's classroom teacher, the Assistant Principal or the Principal by email or on 9347-4822. Please also refer to our Complaints Policy available on our school website.
- to report a potential hazard or incident on the school site, please contact the office on 9347-4822.
- for parent payments, please contact the office on 9347-4822.
- for all other enquiries, please contact our Office on 9347-4822.

School staff will do our best to respond to general queries as soon as possible and ask that you allow us 2 - 3 working days to provide you with a detailed response. We will endeavour to respond to urgent matters within 24 hours, where possible.
